

Arrival/Dismissal Times & Procedures

We are looking forward to meeting all of our camp families in person. Below are some helpful tips to help streamline the arrival and dismissal process.

Prior to Arrival

1. EVERY DAY families will be required to screen each child attending camp for symptoms at home using the check list that was provided in the COVID-19
2. A temperature must be taken each morning at home (100.4 or above - child should remain home)

Arrival/Dismissal General Guidelines

1. Park your car and walk your camper(s) to their designated camp “check-in” area to sign in your camper with their counselor.

- If dropping off multiple campers, walk each one to their camp entrance and check in with their assigned counselors.

- Be prepared to tell the counselor your child’s full name & name of the camp that they are registered for.

EX: John Smith, Morning Adventures 4/5, Under the Sea, Group A or B

2. Daily Arrival/Dismissal locations remain the same each day.

Signs will be posted and families will be directed to the designated drop off/pick-up locations for each camp.

3. Allergies

Labeled epi-pens and/or inhalers should be given to their assigned counselor every Monday Morning of camp. Items will be returned at Friday dismissal.

4. Parking:

All campers use the Rhode Island Avenue Entrance EXCEPT Theater Camp, which use the Gibbs Avenue Entrance.

5. Consistency

We request that the same person pick-up/drop-off campers as much as possible.

6. No Entry

Families/Caregivers are not permitted to enter the school or grounds.

7. Pick-Up procedures for anyone other than Caregivers

Campers will only be released to caregivers or those listed on the pick-up authorization form that was filled out during registration. To add someone, log into your account at: <https://smcdscamps.campbrainregistration.com>.

These individuals will also be required to present a photo I.D. for their initial pickup.

Your promptness is greatly appreciated, as many of our counselors go directly to their extended camp day position after dismissal.

3-Year-Old Morning Adventures

Pick up time is always 1pm at the same spot where campers were dropped off in the morning (at the gate entrance to the early childhood playground to the far left)

4 & 5-Year-Old Morning Adventures

Half day pick up is a 1pm at the same spot where campers were dropped off in the morning (at the front door to the early childhood building/camp entrance)

4 & 5 Childcare After Camp Dismissal (age 4 and 5 only)

- Campers must be pre-registered for one of two pick up times.
- Campers must be picked up only at 1:45pm or 2:45pm.
- Pick up location will be outside at the Early Childhood Playground Entrance gate. In the case of rain- pick up will be at the same place as morning drop off.

Sports Camp, Junior Adventures Camp, Enrichment Camps

Pick-up 1pm half day or 2:45pm full day at the same spot where campers were dropped off in the morning.

Late Pick-Ups: Campers that are picked up late will incur a \$15 fee for every 15 minutes past the designated pick up time.

GENERAL SAFETY MEASURES

Arrival: There are designated zones where we ask everyone to wait to be checked in.

Families/Caregivers/Visitors are not permitted to enter the school or grounds during camp hours of operation.

If possible, we request that the same person pick up and drop off students each day.

Reminders: There will be safety reminders throughout the day to wash hands, cover coughs, avoid touching faces and not sharing personal items. Camp sizes are limited.

Staff Training:

Counselors will promote healthy hygiene practices by going over safety protocols/techniques at the beginning of each week. This includes frequent reminders for hand washing. Signs will also be posted around the school campus to reinforce these healthy habits.

Cleaning and Disinfecting: Intensified cleaning and disinfection practices will be conducted within our facilities and premises.
